## Rules and Policies

All patrons are requested to read and observe the following rules and conditions. These Rules & Policies are effective as of 22 August 2023.

### **Arrival and Departure:**

All accommodation fees to be paid in advance.  
The gates to the grounds are locked every evening and reopened in the morning. The caretaker will provide an access code for the lock.  
Our onsite caretaker will direct you to a parking area/site.

### **Sites:**

The use of our facilities is for holiday, **casual camping only** with a maximum of a 7 night stay. Extended stays may be considered by the Management Committee of the Nanango AP&M Society Inc. This must be requested in writing through the Secretary's office and approved prior to your stay.  
Please keep your site clean & tidy and dispose of all rubbish responsibly.

### **Visitors:**

Guests are responsible for their visitors' behaviour. Please ensure visitors have vacated the grounds by 10pm.

### **Vehicles:**

We permit a maximum of two (2) vehicles per site and vehicles must be parked on your site.

### **Speed Limit:**

**In the interest of safety, the speed limit for the grounds is WALKING PACE only, not exceeding 10 kph.**

### **Noise and Behaviour:**

In the interest of all guests enjoying their stay, we ask that excessive noise is ceased by 10pm. Music & TV's should not be audible to adjoining sites. Parents are responsible for ensuring their children do not disturb the peace & quiet of other park guests. Offensive behaviour or rowdy parties will not be tolerated and will result in the offenders being evicted from the grounds.

### **Children:**

Children must be supervised by an adult at all times and when visiting the amenities block.

### **Fires and Open Flames:**

No fires on the ground. Open fires are only permitted in a fire vessel. No fires or open flames are permitted during Total Fire Ban days.

### **Smoking:**

No smoking is permitted in any buildings and enclosed public areas. Cigarette butts must be disposed of appropriately. No smoking is allowed in Market areas.

### **Property:**

Any person found to be damaging showgrounds property or that of other guests will be evicted from the park and will be held responsible for the repair costs.

### **Trees and Landscaping:**

Removal or damage to trees, shrubbery or grounds is strictly prohibited.

### **Wildlife:**

Please be aware that there is wildlife within the grounds. We strongly advise against feeding them as they are wild animals.

### **Tree Risk**

We have many trees on the grounds that can drop branches and debris. We cannot accept any responsibility what so ever for personal injury or damage to personal property from falling branches or debris.

### **General:**

Prices, rules and policies are subject to change without notice. Nanango AP&M Society Inc reserves the right to evict any person who fails to obey the rules. Eviction from the park will result in forfeiture of all monies paid.

### **Pet Friendly:**

To ensure that you enjoy your stay with all of our other guests, we must ensure that all pet owners take full responsibility for their pet & ensure they do not disturb other guests when on the property. Please read the information below to ensure you and your pet can meet the following conditions: **Dogs and cats must be supervised at all times & never left unattended.**

- When on the grounds, pets must be kept on a leash & under your control at all times.
- Pets are not permitted in any of the buildings on the grounds, **including the amenities buildings**

- Owners are responsible for cleaning up after their pets, which includes toilet duties too!
- All pet owners, whether you have expressively agreed or not, assume all liability regarding your pet being on our grounds & indemnify us against all and any damages, all or any claims or other suits that may arise as a result of your pet being anywhere on our ground.
- Nanango AP&M Society Inc reserves the right to evict and withhold any refunds from guests whose pet is deemed noisy, disruptive and/or aggressive, or is the subject of a complaint/s from other guests.

### **Riding of bicycles & scooters on Showgrounds:**

It is a mandatory requirement that all persons using the above **MUST** wear a securely fastened helmet at ALL TIMES.
