This notice will inform you of the rules by which we must abide as part of Dogs NSW Covid-19 Safety Plan. A copy of our plan can be seen and downloaded from the files section of our Face Book page.

Please remember the following conditions, as part of your entry:

- Please bring your own mask and hand sanitiser. Hand sanitiser will be available on the table at the front of the Secretary's Hut at all times, but it may be preferable to bring your own.
- Show Manager will email your Exhibitor number (s). If you forget your numbers, please see the Show Secretary, Lynne Cook.
- All persons attending the show are required to register their full name and a telephone contact. Show Manager will include a mandatory contact sheet to be completed with your entry

At the Show:

- The Show will commence with Property Classes at 9am, followed by breed classes (Breed classes will not commence before 10am).
- Gazebos must be set up according to social distancing regulations as set down in the Covid-19 Plan and according to NSW Government Health regulations.
- Please listen carefully to instructions by the Show Secretary and your Ring Steward. Social distancing will be enforced by your steward in the ring and we do expect all Exhibitors to show respect to officials and each other at all times.
- Photos will be permitted
- The wearing of masks will be dictated by the NSW Government Health Department at the time of the Show and will be advised to exhibitors prior to the commencement of the Show.
- In the ring, Exhibitors are required to maintain social distancing regulations and will be directed as such by your steward.
- Exhibitors will be asked to mouth their own dogs. Please be respectful of our judges when they direct you to do this.
