All Exhibitors must abide by the COVID Safety Plan that has been agreed with the ACT Government to allow these shows to be conducted.

CONDITIONS OF ENTRY

- If you have even mild symptoms, please stay away and get tested.
- Dog exhibitors must enter the grounds via Old Well Station Road off the Federal Highway. There are disabled car parks close to the upper entry however on this weekend our rings are bottom rings.
- Attendees are encouraged to have downloaded the COVID safe app at https://www.health.gov.au/resources/apps-and-tools/covidsafe-app
- Entries are open to all states.
- Entries will not be accepted from a high-risk category as per any current ACT Government advice at https://www.covid19.act.gov.au/home
- Online entries only via Show Manager and will require acceptance of terms laid out in the COVID 19 page to enable attendee tracking.
- All persons who are not officials or exhibitors must register their attendance at the office.
- There will be no paper Catalogues issued at this event.
- The Catalogue will be available online prior to the event.
- It shall be the exhibitors responsibility to print their own exhibitor numbers.
- Gazebos must be spaced a minimum of 1.5 metres apart.
- Only members of the same household can share a gazebo.

PHYSICAL DISTANCING

- There shall be no congregating or setting up on pathways or under ring awnings.
- Keep a distance of 1.5 metres between yourself and other people.
- Practice good hygiene at all times.
- No person shall encroach on the Steward's safety zone (1.5 metres)
- Masks are encouraged.
- Hand sanitiser will be available, but exhibitors should bring their own.
- Exhibitors shall enter the ring area via the entrances and exits signposted and maintain physical distancing at all times.
- Ring equipment shall be regularly sanitised during the event
- Exhibitors are requested to maintain appropriate hygiene and physical distancing when visiting restrooms.

JUDGING

- The exhibitor shall be responsible for mouthing their exhibit
- The exhibitor will be responsible for adhering to physical distancing requirements when in the ring with other exhibitors, exhibits and officials.

CAMPING

• Camping facilities are available at the dedicated Exhibition Park in Canberra (EPIC) camping area. Absolutely no camping is permitted in the car park or across the road from the Dogs ACT rings.
