**** PLEASE READ IMPORTANT INFORMATION FOR ALL EXHIBITORS ****

While COVID-19 restrictions have eased & there is no longer a requirement for ACT events to have in place a COVID plan, the Hound Club of the ACT are aware that many exhibitors do not want to catch any virus. As such we would ask that everyone abides by the following conditions of entry for the weekend of four (4) championship shows.

CONDITIONS OF ENTRY

- If you have even mild symptoms, please stay away and get tested.
- Dog exhibitors must enter the grounds via Old Well Station Road off the Federal Highway. There are disabled car parks close to the upper entry.
- Entries are open to all states.
- Online entries only via Show Manager and will require acceptance of these conditions.
- There will be no paper Catalogues issued at this event.
- The Catalogue will be available online prior to the event.
- It shall be the exhibitor's responsibility to print their own exhibitor numbers.
- Gazebos must be spaced a minimum of 1.5 metres apart.
- No dog with any known symptoms of disease should be brought to these events.

PHYSICAL DISTANCING

- There shall be no congregating or setting up on pathways or under ring awnings.
- Please keep a distance of 1.5 metres between yourself and other people.
- Practice good hygiene at all times.
- No person shall encroach on the Steward's safety zone (1.5 metres).
- Masks are encouraged.
- Hand sanitiser will be available, but exhibitors should bring their own.
- Exhibitors shall enter the ring area via the entrances and exits signposted and maintain physical distancing at all times.
- Ring equipment shall be regularly sanitised during the event
- Exhibitors are requested to maintain appropriate hygiene and physical distancing when visiting restrooms.

JUDGING

- The exhibitor shall be responsible for mouthing their exhibit when requested to do so by the judge.
- The exhibitor will be responsible for adhering to physical distancing requirements when in the ring with other exhibitors, exhibits and officials.

CAMPING

- Camping facilities may be available at the dedicated Exhibition Park in Canberra (EPIC) camping area as well
 as across the road from the rings in the Bicentennial Gardens. All bookings MUST be made prior to the
 event by booking via SHOW MANAGER only as entries close only 36hrs prior to first shows. No on the day
 bookings will be accepted & EPIC may ask you to leave the grounds if you have not booked.
- Do not contact Dogs ACT for any camping requirements.
