TRIAL PROCEDURES

Please be courteous and respectful to all judges, stewards and other competitors.

All parking between the Upper and Lower Rings is reserved for judges, stewards and trial helpers.

No Competitor parking beyond the edge of the Upper and Lower Rings is permitted. If you have parked somewhere incorrectly, you will be asked to move your vehicle.

AWARDS

Sashes and prize for first, second and third (Qualifying Scores only). Qualifying Ribbons available.

PRESENTATION

Presentation will be after completion of each session to discuss search and announce placegetter. Pass cards will be available for collection by competitors as they exit the search area. Competitors not wishing to stay to the end of the session and who have not volunteered to assist may leave after their searches complete.

CHECK IN TIMES

Novice, Master, Excellent: For dogs entered all numbers must be personally collected between 7:00 am – 7:30 am from the Check In desk.

Advanced: For dogs entered all numbers must be personally collected no earlier than 1:00 pm from the Check In desk. Advanced class will commence no earlier than 1:30 pm.
