Unfortunately, we cannot guarantee that everyone who may be eligible to track on will be able to do so.

Please note that passes towards any tracking title must be gained under **at least two judges**, so if any passes towards your dog's current title have been awarded by **either of the judges** who are officiating at this trial, please inform the Trial Secretary.
