CHECK IN TIMES

All bitches will need to be vetted.

Competitor numbers are to be pre-printed by competitors (preferred) or written on blanks at check-in desk.

TOILETS

Toilets are located to the right of the parking area and beside the Trial Area (Upper Rings) (not to be used during Nov/Adv Ext, Adv Con).
