CHAMPIONSHIP STAKE: Confined to Gundogs that have been placed first in a Restricted Stake or first, second or third in an All-Age Stake or have the title All Age Retrieving Dog. A variety of game within rules will be used. Proof of eligibility <u>MUST</u> be provided with entries for any non-titled dog prior to close of entries.

<u>IMPORTANT NOTE:</u> ALL dogs and their handlers that finish the Championship <u>are expected</u> to remain on the grounds until ALL judging is complete and <u>are EXPECTED</u> to stay for the trial prize-giving presentation and photographs. This is essential to retain future sponsorship.

AWARDS: Trophy and Sash 1st to 5th Place (for qualifying dogs only). A team event will be run as per previous years.

ENTRY FEES: \$50.00 per dog. All entry fees made out to <u>"Dogs NSW Retrieving Trial Championship"</u>. Catalogue included with entry fee. Non exhibitor catalogues – \$5.00 per catalogue.

Fees MUST accompany a correctly completed entry form and include a stamped and self-addressed envelope. Incomplete or illegible forms may be returned. Directions and map for the campsite will be sent along with your

receipt. Please provide an email address with all entries to allow prompt receipting of entries and notification of updates.

The committee reserves the right to appoint additional or substitute judges with or without notice.
