Please note, handlers of desexed bitches entered in your trial who have proof of desexing are not required to be vetted or stand in the vetting queue and are to proceed directly to the checkpoint where their proof is verified.

From 1st January 2001, the SACA Rules state lost entries are not to be accepted on the day of the trial. Exhibitors whose entries are not catalogued *may not* compete under any circumstances, except where the Secretary and/or Club is found to be at fault.

It is also to be noted the names of non-affiliated Clubs are not to be printed in your catalogue. A full list of affiliated Clubs is published in the Dogs SA journal.

Please ensure the marked catalogue/s together with the original Judges scoresheets are forwarded to the Dogs SA Office within 14 days of the exhibition.
