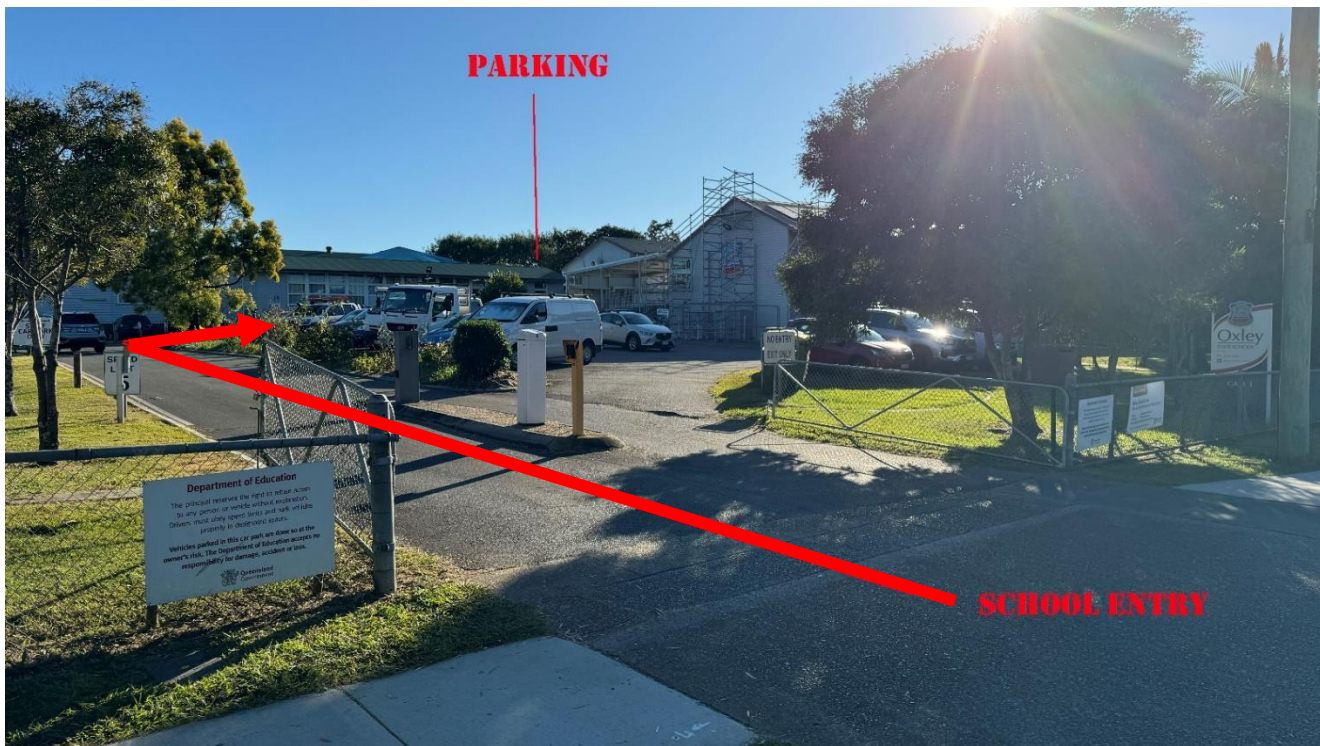

PARKING

Please enter via the Bannerman St entry. The carpark is immediately on the right as you enter, however, you need to drive about 50m into the school to the carpark entry. Please see map and photos below.





Car parking will be tight however all 17 competitors can fit if everyone parks thoughtfully. The photo below demonstrates how this area can be used for additional spaces.

There is NO separate reactive parking. We ask that competitors please be considerate of their fellow competitors and give them as much space as possible (as you usually do, thank you!). For those competitors with reactive dogs, we recommend you bring some screening, window covers or a gazebo with sides to place over your vehicle in case your dog needs additional line-of-sight screening.



CHECK-IN PROCEDURE

1. Please check-in between 3 and 3.15pm for BOTH trials. Check in will be in the carpark.
2. If you have an entire bitch you will need to have her vetted. Please contact a trial official to accompany you to your vehicle to complete vetting.
3. Competitor numbers have been emailed out for both trials. Please print or write them out prior to arrival.
4. Walk throughs of the search areas will start at 3.30pm so the trial can start promptly at 4pm.

DOGGY TOILETING

At all times you shall be responsible for cleaning up after your dog/s. There is very little grass area available because of construction work, so you may need to leave the grounds to toilet your dog. Excessive barking will not be tolerated, please be very mindful of nearby residents.

HUMAN TOILETING

We will be sharing the toilets in the school hall with Taekwon-Do from 5-7pm. Please be respectful of the shared space and do NOT take dogs with you. To avoid seeing search areas, it is important that all competitors follow the cones and stay within the barricade tape from the parking area to the toilets. Do NOT take the direct route to the toilets, past the no-go zone, or you risk disqualification.



CATERING

There will be no catering at this trial. There are nearby shops located further along Oxley Road (1118 Oxley Rd), McDonalds Oxley (2098 Ipswich Rd, Oxley), Subway (Shop 9/2118 Ipswich Rd, Oxley) or at Woolworths at the Oxley Station Shopping Centre (133 Oxley Station Rd, Oxley).

QUALIFYING CERTIFICATES AND AWARDS

Qualifying certificates will be issued at the end of both trials.

Rosettes are available for qualifying competitors and ribbons for 1st, 2nd and 3rd (qualifying scores only).

RUNNING OF THE TRIAL

Trial 1 will commence at 4pm. Trial 2 will commence as soon as Trial 1 has finished.

Because we have only a small number of competitors, and to avoid dogs being kept waiting too long, competitors will be expected to largely self-manage.

Warm up boxes will be available next to the carpark.

Trial 1: please note there is approximately six solid steps with non-slip treatment linking the classroom and adjacent exterior areas.

For both search areas, there will be a single station between the carpark and the search. These stations will be in line of sight from the car-park, so please make your way to the station when the previous competitor has been called into the search (via the warm up boxes if you wish). You wait at this station until you are called. There is no rush but please make sure you are on-deck within a few minutes of the previous competitor leaving. This will be explained at briefing.
