- 3. Competitor numbers have been emailed out for both trials. Please print or write them out prior to arrival.
- 4. Walk throughs of the search areas will start at 2.45pm so the trial can start promptly at 3pm.

At all times you shall be responsible for cleaning up after your dog/s. Excessive barking will not be tolerated, please be very mindful of nearby residents.
