Any dog running in a muzzle along with all FCH and Open dogs are to present to the trial secretary.

Any dog that does not present will not be permitted to run.

Formal vetting will not be conducted but Fast Paws Sydney Inc reserve the right to vet any dog present on the grounds. **Bitches in oestrus may not be trialed or present in the trial precinct.** Fast Paws Sydney Inc reserve the right to appoint additional or substitute judges with or without notice if necessary and to amend order of judging pending entries received.

This trial is being run under the Rules and Regulations of DOGS NSW. A copy of the regulations may be perused at the Trial Secretary's table. The Committee reserves the right to alter or amend judging arrangements and to substitute judges if deemed necessary.

In accordance with DOGS NSW Regulations Part II Show, it is the obligation of each owner, exhibitor and handler at a show to take all such steps as may be necessary to ensure that any dog under person's care or control, or for which that person is responsible, does not behave in an aggressive manner. It is the obligation of any person who observes a dog behaving in an aggressive manner to report the incident either orally or in writing to the Trial Secretary as soon as possible on the day of the event.
