IMPORTANT – PLEASE READ

CARPARK ENTRANCE

Please enter via David Low Way. The carpark is immediately on the left as you enter.

PARKING

Car parking will be tight however everyone can fit if everyone parks thoughtfully.

All parking to the right as you enter is reserved for judges, stewards and trial helpers (non-dog vehicles)

There is a small space around the side of the castle available for reactive dogs, and there is also parking available in the service road just prior to the castle entryway.

We ask that competitors please be considerate of their fellow competitors and give them as much space as possible (as you usually do, thank you!). For those competitors with reactive dogs, we recommend you bring some screening, window covers or a gazebo with sides to place over your vehicle in case your dog needs additional line-of-sight screening.

Dogs not competing or being toileted must remain crated or in their vehicle.

REACTIVE DOGS

This is a Reactive Dog Friendly trial. **Please be considerate of your fellow competitors**, if they ask for space please do everything you can to help. If in doubt, give them space! And do not be afraid to advocate for your dog if you need some help. Just let others know 😊

It is recommended to bring window coverings for reactive dogs should your dog require additional line-of-sight screening.

CHECK-IN PROCEDURE

For dogs entered all numbers should be pre-printed, and competitor attendance checked off as per the Group Check-in times in the table below. Please confirm or correct your Club Represented (if any) at Check-In.

Please do not bring your dog to check-in. All entire bitches will need to be vetted and are marked in **RED** in the catalogue. Please let the check-in steward (Group 1) or carpark marshal (Group 2-3) know you have an entire bitch and they will accompany you to your car to complete vetting.

GROUP 1 - Please check-in at carpark between 5:15PM and 5:45PM for BOTH STREAMS trials.

1. If you have an entire bitch you will need to have her vetted. Please contact a trial official to accompany you to your vehicle for vetting.
2. Competitor numbers have been emailed out, please print or write them out prior to arrival.
3. VIDEO walk through will be posted at approximately 8:15AM in the FB Ultimate Trial Group.

DOGGY TOILETING

At all times you shall be responsible for cleaning up after your dog/s. There is grass available at the edge of the carpark (adjacent the shipping containers) and you must collect and take all poop with you. Excessive barking will not be tolerated, please be very mindful of nearby residents.

HUMAN TOILETING

There are toilets located as marked, however you will need to go to the toilet between competitors as access to the toilets is through the search area. If you REALLY REALLY need to go, there is a Shopping Centre at the roundabout before you turn in to the Castle.

COMPETITOR BRIEFING

Competitor Briefing will take place virtually. The video walkthrough will be posted in the Queensland Scent Work FB Group 8:15AM approx.

PRESENTATION

Pass cards will be issued digitally after the completion of the trial. Competitors not assisting with the trial are free to leave after their searches. Presentation will be held after completion of judging for those remaining.

CATERING

There will be catering at this trial, available at the Castle Café from 8:00AM onwards.

COMPETITORS

If you wish to withdraw from a class, or need to run out of order, you must notify the Assembly Steward in person. If any details in the catalogue are incorrect it is your responsibility to advise the Trial Secretary as soon as possible.

Competitors are responsible for cleaning up after their dog/s. Excessive barking will not be tolerated – please be very mindful of the nearby residents and other competitors. Rudeness and aggressive behaviour towards any Trial Officials or Helpers will not be tolerated. Should confirmed abusive behaviour be reported, offending competitors ***will be removed from the trial.***
