Trial details:

- Online entries only: <https://showmanager.com.au>
 - Ultimate: \$35.00 per entry – capped at 15 entries
 - Ultimate Not for Competition: \$25.00 – capped at 10 entries
- Ultimate Not for Competition requirements
 - Scent Work Rules s6.3 Non-titling Classes: “An affiliate conducting a Scent Work trial may, at its discretion, offer non-titling Classes. Qualifying Certificates cannot be awarded for these Classes.”
 - Eligibility: This Class is open to those dogs that:
 - do not meet the requirement for the Ultimate Class - refer Rules s 6.1(e) – in sum, if you have your Scent Work Master title or two Element titles
 - have achieved a minimum of one Element title or four Master qualifications in any of the four Elements – proof may be required
 - **Entry preference** will be given to ACT and region trialers until **COB 17 October 2025**. Any remaining spots will be opened up to other trialers after this date
 - This Class will be run under the same trial conditions as the Ultimate Class.
 - Trialers entered in the Ultimate Class wishing to run a second dog in the Ultimate Not for Competition Class will need to register a second handler who meets the eligibility criteria for Dogs Australia trials ie current financial member of a member body
- Running order will be provided at the event and on Canberra Canine Nosework Facebook site
 - Ultimate Class will run first
 - Ultimate Class Not for Competition will follow the Ultimate Class
- Gate and parking details will be provided with the running order
- **Trial timings:** Check-in 8:30 am to 9 am. Handlers’ briefing 9.15 am. Judging commences at 9.30 am. This includes both Classes
- Ribbons for 1st place, 2nd place, and 3rd place and titles

NOTE: ACT GSDA will also hold a trial (Ultimate; Ultimate Not for Competition) on 2 November 2025 providing two opportunities for both Classes

Additional Information

- A separate entry form must be submitted for each entry (Scent Work Rules s8.1.2)
- Handlers must only enter the Classes/Elements they are eligible to enter (Scent Work Rules: s6.1 and s6.2)
- No upgrades will be allowed after the trial closing date

- At any trial a dog may be entered in only one (1) Class within an Element
- Only one dog/handler per Class/Element. An owner entering two dogs in the same Class/Element must advise the name of a second handler (who is current and financial with a member body). Dogs from the same family will run concurrently
- Handlers should not visit the trial location prior to the trial date
- Dogs ACT reserves the right to make any changes that will ensure the smooth conduct of the trial, to substitute or appoint additional judges and to accept or reject entries.
- No target odour to be brought to the grounds. No scent work training on the grounds during the trial
- Bitches in oestrus may NOT be trialled
