- If you have ever competed in a Sprint Dog trial (whether successful or unsuccessful), you are not eligible to enter.
- Any ineligible entries will be rejected without refund.

Entries will be capped.

Judges/Stewards/Volunteers will be exempt from the above. If the cap is not reached in the week of entries closing, we will open remaining places to everyone and this will be notified on our Fast Paws Sydney Inc Facebook group page.



This event will be using a continuous loop lure and an enclosed catching pen.

Entries Closing: 9am 1 December 2025. No refunds or changes after this time
