This impressive, elegant saluki shown to perfection caught and held my attention from the moment he entered the ring with his quality and ring presence. He was harmonious and graceful from the tip of his nose to the end of his feathered tail, exhibiting smooth, clean movement that was simply effortless, showcasing power with excellent reach and drive. This dark red, black-fringed dog, just shy of seven years of age is still capable of great speed and endurance and could fulfil his breed function. He is pleasingly moderate with a symmetrical outline. Handsome head that is very breed typical with correct proportions, oval eyes and the black fringing on his ears perfectly framing his pleasing head. Long graceful neck which transitions well into his shoulders, good prosternum, fill, depth of chest that is well ribbed back, slight muscular arch over the loin, great tuck-up to aid function, correct hindquarters, good blade bone and feet. This dog could not be denied the dog challenge and ultimately, Best in Show based on his breed type, breed attributes and quality.

To say that I was delighted to receive the invitation to judge at the Saluki Club of NSW Specialty, is an understatement. I have followed the breed for many, many years but have never been an owner, even attended the first Australian Saluki Specialty judged by the late Thelma Gray, held at St Ives Showground.

I was fortunate to have seen many of the early greats and influential dogs in Australian pedigrees and in addition, saw Marco Leynor judge the San Angeles Saluki Specialty in 1976 in California, where I was lucky enough to see some of the world famous Jen Araby dogs and some of the Chubasco dogs. It was an education to watch one of the breed's masters judge that extraordinary entry and it has stayed with me ever since.

I've been licensed to judge the hound group since 1989, but on the way through the "parade system" in South Australia I recall I awarded a group to Imray El Hor Bethesda, a red bitch owned and bred by Monica and Sue Smith. She was a wonderful mover and nothing like any of the Salukis I had seen in this country prior to judging her. She actually took my mind back to that San Angeles Specialty that I had attended 12 years earlier.

As exhibitors are probably aware, I am not a breeder of Salukis but have bred Afghan Hounds since 1977. They are not the same by any stretch, so many fundamental differences between the breeds but at the same time, so many similarities that tie both breeds to basic Sighthound type.

Not just pretty faces, but hunting machines, a fact that will never be lost on me.

Looking forward to a rewarding day, and thankyou once again for this prestigious invitation.


