- \* LIMIT OF 2 DOGS PER REGISTERED SHOW MANAGER ACCOUNT
- \* DOGS MUST BE REGISTERED IN THE NAME OF THE SHOWMANAGER ACCOUNT HOLDER. (FULL OR CO-OWNER)
- \* YOU MAY ENTER ALL 3 INDIVIDUAL BALLOTS, HOWEVER YOU CAN NOT RUN THE SAME DOG IN MORE THAN 1 TRIAL.
- \* IF YOU DELETE YOUR ENTRIES WE WILL NOT REINSTATE THEM
- \* ANY SUCCESSFUL ENTRIES NOT PAID FOR BY THE NOMINATED DATE AND TIME WILL BE REMOVED
- \* DOGS MUST BE OVER 12mths OF AGE
- \* ALL DOGS RUN INDIVIDUALLY
- \* NO BITCHES IN SEASON OR SHOWING DISCHARGE CONSISTENT WITH BEING IN SEASON
- \* NO PREGNANT BITCHES OR BITCHES MUST BE 12 WEEKS POST WHELP TO COMPETE
- \* DOGS MUST BE UNDER EFFECTIVE CONTROL AT ALL TIMES WHEN YOUR DOG IS RUNNING INSIDE THE SprintDog TRACK
- \* PLEAE ENSURE YOU HAVE A PERSON TO HELP CATCH OR RELEASE YOUR DOG
- \* DOGS MAY RUN IN A FLAT COLLAR ONLY. NO HANGING STRAPS OR TAGS
- \* ALL DOGS WILL RUN IN RUN 1. IF YOUR DOG DOES NOT COMPLETE RUN 1 OR IS EXCUSED OR DISQUALIFIED, IT WILL BE INELIGIBLE TO RUN IN RUN 2.
- \* RELEASERS AND CATCHERS MUST BE A FINANCIAL MEMBER OF A DOGS AUSTRALIA MEMBER BODY
- \* DOGS MUST BE REGISTERED ON ONE OF THE DOGS AUSTRALIA REGISTERS.
