
IMPORTANT TIMES

Competitor Carpark Access: From 2:15PM (NO ACCESS PRIOR TO THIS TIME)

Check In: Group 1: 2:30PM – 2:45PM, GROUP 2: From 4:30PM/ad hoc

Walk Throughs: 2:45PM (Video posted)

Judging: Group 1: 3:00PM, GROUP 2: From 5:00PM



PARKING

Please enter via Gogg St, the driveway is immediately after the entry to the Animal Emergency Service hospital. Please see map above and photos below.



Car parking will be tight however everyone can fit if everyone parks thoughtfully.

There is NO separate reactive parking. We ask that competitors please be considerate of their fellow competitors and give them as much space as possible (as you usually do, thank you!). For those competitors with reactive dogs, we recommend you bring some screening, window covers or a gazebo with sides to place over your vehicle in case your dog needs additional line-of-sight screening.

CHECK-IN PROCEDURE


1. GROUP 1 - Please check-in at carpark between 2:15PM and 2:45PM.
2. If you have an entire bitch you will need to have her vetted. Please contact a trial official to accompany you to your vehicle to complete vetting.
3. Competitor numbers have been emailed out for both trials. Please print or write them out prior to arrival.
4. VIDEO walk through will be posted at 1:45PM in the FB Ultimate Trial Group.
5. GROUP 2 – Please mark yourself off on the check-in list once you arrive.

DOGGY TOILETING

At all times you shall be responsible for cleaning up after your dog/s. There is plenty of grassed areas available at the front of the property and along the sidewalk but you must collect and take all poop with you as there will be no poop bins available.

HUMAN TOILETING

To avoid seeing search areas, it is important that all competitors follow the directions from the parking area to the toilets. Do NOT take any other route to the toilets or into any marked “no-go zone” (see red zone below), or you risk disqualification. **If using the toilets at the Coles complex, please use the driveway AFTER the liquor store and not the one that runs immediately adjacent the search area. Toilets are also available at McDonalds, near Subway, at the Fuel Station and at Guzman y Gomez.**



CATERING

There will be no catering at this trial. There are nearby shops located at the Coles complex (café), opposite the AES Hospital (Subway etc.) and at the roundabout (McDonalds).

QUALIFYING CERTIFICATES AND AWARDS

Qualifying certificates will be issued electronically after the trial.

Rosettes are available for qualifying competitors and ribbons for 1st, 2nd and 3rd (qualifying scores only).

RUNNING OF THE TRIAL

- The Trial will commence at 3:00PM, except for the **highlighted** dogs who will run PRIOR (Shadow Judges, competing Demo dogs).
- Competitors will be expected to largely self-manage.
- Warm up boxes will be available next to the carpark.
- There is no rush but please make sure you are on-deck for your search within a few minutes of the previous competitor leaving.
- You may leave as soon as you have run, However, if you are leaving early, please arrange for someone to collect your place ribbon/prize if required.
- IF YOU ARRIVE BEFORE 2:15PM, please wait in your car. .
- Demo Dogs ONLY are to be out of cars in the trial precinct prior to 2:30PM.

ULTIMATE Search:

- There will be a single station under the front awning of the building, so please make your way from the carpark when the previous competitor has been called into the search.
