**Vetting:** No formal vetting will be conducted. However, the club reserves the right to vet any dog on the grounds.

**Awards:** Qualification and title Ribbons at the end of last runs and pack up.

**Entry fee:** Members - \$20. Non Member - \$25

Online entries only, via Showmanager

★ Registry dogs only.

**Catalogue / running sheet:** provided free on Showmanager.

Entries capped at 100 total.

**LIMITED ENTRY** – 2 dogs per household, per account.

**Measuring Dogs:** Owners will need to fill in the height card before presenting the dog for measurement. Blank height cards will be available on the day.

## Important Information for the trial

- Dogs must have their Showmanager profile linked to the Dogs Australia database ie. be a Registry dog.
- A second handler will not be supplied to exhibitors. It is solely up to the owner of the dog to arrange a second handler.
- No person has to take responsibility for a dog they are uncomfortable with. Should a handler feel uncomfortable with a dog they may return it to the owner **AT ANY TIME.**
- Exhibitors need to arrange their own handlers. You must nominate your Releaser and Catcher when entering and both must be financial members of DOGS NSW (or equivalent state body) and over 16 years of age.
- Both Releaser & Catcher require a lead i.e. Two leads per dog.
- Dogs that win the ballot are the dogs that are entered, **Changes will not be made.**
- Exhibitors bring their dog's height card. Dogs without a card will be measured at check-in. Please fill in a height card before presenting your dog for measurement. Blank height cards will be available on the day.
- All dogs that are eligible may attempt Run 1. Only dogs that successfully complete this run without being excused or disqualified will be eligible to attempt Run 2.
- Please warm up your dog away from the Sprint Zone and exclusion areas.
- **Bitches in season are not allowed to compete or allowed on the grounds.**
- Bitches must be a minimum of 10 weeks post whelp to compete. Mated bitches or bitches in whelp may not compete.
- The Club reserves the right to make any changes to ensure the smooth conduct of the event, to cap entry numbers and to accept or reject entries.
