Order of judging will be as per catalogue. Where a handler has more than one entry, every effort has been made to ensure that his/her presence in the rings will not coincide. If you have a clash please notify the stewards at the ring.

Bitches in oestrus may not be trialled and are not allowed within the precincts of the Trial ground.

No dog, with the exception of those under Judge's command, may be permitted off lead. Ensure dogs are always kept under control.

It is the obligation of any person at this trial who observes a dog behaving in an aggressive manner to report the incident either orally or in writing to a member of the committee as soon as possible after the incident ON THE DAY OF THE TRIAL.

SAFETY BRIEFING NOTICE

Trials are held over undulating and hazardous terrain. All competitors, stewards and spectators must take all care while on the trial site. As with all outdoor activities it is suggested that competitors, stewards and spectators have weather appropriate clothing and sturdy, closed in and puncture resistant supportive footwear that is in good condition and take due care when moving around the trial site. Remain alert, particularly for snakes as these can remain active even in cooler weather.

The trial is located near water. If you cannot swim take care around water. If you have children in your custody, it is your responsibility to ensure their safety and welfare at all times, especially near water.

Equipment used in trials is mechanical and if used incorrectly could cause injury. If you are unsure regarding the operation of the equipment please advise committee so that appropriate instruction can be provided. Do not touch any equipment on the trial site that is not involved with the conduct of the trial.

Any personal equipment or property brought onto and/or used at the trial site is done at the owner's discretion and remains the responsibility of the owner. NSDTC (and its insurers) are not responsible or liable for any damage to such equipment or property.

First aid is available at the trial site and if required please inform the Trial Manager.
