Dog Jump Height is to be included for all Open & UD, Rally Advanced and Excellent entries.

Entries must be from the Main or Limited Register to be accepted as a condition of entry. The GSDCV reserves the right to appoint additional judge(s) if entries are excessive.

For Dual Trophy purposes: (Obedience entries also competing in conformation classes at the GSDCV 11th April 2026 Breed Exhibition) please indicate which conformation class the obedience dog will be entered in.

For Catalogue purposes: Handlers also competing with other dogs in Conformation classes at the GSDCV 11th April 2026 Breed Exhibition should note this information on entry to assist with catalogue generation and competing order. CCD and Novice individual entries may be taken out of order to enable conformation classes to proceed.

## Judging Order and Commencing Time

Obedience Judging commencing at 9am

Rally Judging commencing approximately 60 minutes after the completion of Obedience Presentation.

10 minute course walk before commencement of Rally Judging.

Ring 1: Obedience: UDX followed by UD followed by Open

Rally Master followed by Excellent followed by Advanced followed by Novice

Ring 2: Obedience: CCD and Novice

**Check in time for collection of Exhibit numbers and Vetting** 8.15am to 8.45am (for Obedience and Rally) or  
(Conformation competitors note this is a separate check in) Rally only 10.30pm – 11am
