- Scent work training must not be carried out on the trial grounds during the trial.
- Competition odours must not be brought to the trial precinct by competitors.
- Attendees are reminded not to speak about the search areas at the trial prior to completion.
- Please be familiar with the Scent Work Rules especially regarding the eligibility to enter and spectating.
- Judging may commence with stewards' dogs followed by the remaining competitors.
- If excessive entries, a ballot may be required and will be held on 31 March 2026 at KCC Park Rm 4.
