Class: 100m. This event will be using a continuous loop lure and will have an enclosed catching pen.

Entries capped at 140 dogs per day.

Entries open: 1 February 2026. Online entries via Show Manager Ballot system.

First round Ballot drawn: 8 April 2026
(Payment due by 9am 10 April 2026)

Second round Ballot drawn: 13 April 2026
(Payment due by 9am 15 April 2026)

Those successful will be notified by email (Show Manager). Withdrawals must be made by **22 April 2026 at 5pm**. No refunds or changes after this time.

Entry Fees: \$25 per dog.
(Maximum 2 entries per household. No exceptions).

Check In/Measuring: 7am - 7:30am daily

Trial Briefing: 7:45am daily

Judging Commences: 8am daily

Vetting: No formal vetting will be conducted. However, the club reserves the right to vet any dog in the trial precinct.

Awards: Qualifier Ribbon and electronic certificate (Show Manager).

Titles Gained: Sash.

- ★ All dogs must be a "Registry Dog" with their Show Manager profile linked to the Dogs Australia database.
- ★ Exhibitors need to arrange their own handlers. You must nominate your Releaser and Catcher when entering.
- ★ Both the Releaser and the Catcher MUST be financial members in good standing of DOGS NSW (or equivalent state body) and over 16 years of age.
- ★ Please ensure BOTH handlers have a lead for the dog.
- ★ Exhibitors must bring their dog's height card. Dogs without a card will be measured at check-in. Please fill in a height card before presenting your dog for measurement. Blank height cards will be available on the day.
- ★ All eligible dogs will compete in Run 1. Dogs who are excused or disqualified in Run 1 will NOT be eligible to compete in Run 2.
- ★ Please warm up your dog away from the Sprint Zone and exclusion areas.
- ★ Bitches in season are not allowed to compete or allowed on the grounds.
- ★ Bitches must be a minimum of 10 weeks post whelp to compete. Mated bitches or bitches in whelp may not compete.
- ★ The Club reserves the right to make any changes to ensure the smooth conduct of the event, to cap entry numbers and to accept or reject entries.
