**COMPETITORS**

If you wish to withdraw from a class, or need to run out of order, you must notify the Assembly Steward in person.

If any details in the catalogue are incorrect it is your responsibility to advise the Trial Secretary as soon as possible. Pass cards will be digitally issued after the trial is complete.

At all times a competitor shall be responsible for cleaning up after their dog/s. Excessive barking will not be tolerated – please be very mindful of the nearby residents and other competitors. Rudeness and aggressive behaviour towards any Trial Officials or Helpers will not be tolerated.

**PARKING**

**All parking between the Upper and Lower Rings is reserved for judges, stewards and trial helpers.**

**Please give competitors with reactive dogs space!**

If you have parked somewhere incorrectly, you will be asked to move your vehicle. Please DO NOT park immediately adjacent the warmup areas as these will be very busy and used for marshalling to the warm up boxes.

**CHECK IN TIMES**

For dogs entered all numbers should be pre-printed, and competitor attendance checked off between 5:00 pm – 5:30 pm at the Check In desk at Assembly Area 9. Please confirm or correct your Club Represented (if any) at Check-In.

Please do not bring your dog to check-in. All entire bitches will need to be vetted. Please let the check-in steward know you have an entire bitch and they will accompany you to your car to complete vetting.

**COMPETITOR BRIEFING**

Competitor Briefing will take place at Assembly Area 9 at approximately 5:45pm, dogs may NOT be brought to the Competitor Briefing area.

**REACTIVE DOGS**

This is a Reactive Dog Friendly trial. Please be considerate of your fellow competitors, if they ask for space please do everything you can to help.

If in doubt, give them space! And do not be afraid to advocate for your dog if you need some help. Just let others know 🟡 - - - 😊

Dogs not competing must remain crated or in their vehicle. Anyone who does not comply with trial official direction may be disqualified.

**AWARDS**

Place ribbons and credit for 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place (Qualifying Scores only). Qualifying Ribbons available.

**PRESENTATION**
