If, at close of entries there are insufficient entries to hold a Stake, competitors will be notified. At that time they may request a refund of entry fee, or if eligible, transfer to another Stake at the appropriate fee.

Dogs SA Extreme Weather and Safety Rules apply. If forecast 48 hours prior for Retrieving, Field and RATG; is 32 degrees Celsius or higher must be cancelled, unless there is ample swimming water on the property. [Bureau of Meteorology \(bom.gov.au\)](http://bureau.meteorology.gov.au). No refunds given.

The Trial site is Private Property and must not be revisited following the Trial.

Dogs SA Rules PART VIII EXHIBITIONS C 15. (b) There is to be no training on designated trial grounds within 28 days before trial.
RAFT Covid Plan applies.

Other than in the Exercise Areas designated by the Trial Manager, or his/her delegates, no dogs will be permitted to swim or train in or on the trial grounds. All dogs must be kept on a lead, either held in the hand or tethered, except when competing or being exercised in the designated area. It is the Exhibitors responsibility to find out where the exercise area is at any time on the trial grounds.

Retrieving and Tolderol have a link that goes back to 1964 when the first sanctioned Non Slip Retrieving Trial held in South Australia was conducted on this property. The first running of the "Tolderol Cup" was in 1981 and in 2007 the first "Michael Verco Memorial All Age Stake" was held. We thank the Verco family - Michael (deceased) and Jen, and more recently their son Ack, for their long-term support our sport.

Thank you, as always, to all of our Judges, Stewards, Trial Managers, SACA Rep, and everyone else who steps up to help at this trial.

SAFETY AT RETRIEVING TRIALS

1. The environment, animals and wildlife can be inhospitable. Be alert and avoid any animals and wildlife where possible.
2. Trials are located close to water. Take care around water. If you have children in your custody it is your responsibility to ensure the safety and welfare of the children at all times.
3. Equipment used in trials is mechanical and if used incorrectly could cause injury. If you are unsure regarding the operation of the equipment familiarize yourself on how the equipment works before use.
4. We are privileged to be permitted to run our trials on private property and must respect the property owner's personal property and should therefore:-
 - Remove all rubbish from the property
 - Do not enter any dwellings on the property
 - Do not touch any farm equipment on the property
 - Ensure all dogs are under effective control and on lead especially around any livestock (except when actually competing and under instruction of the judge)
 - All gates must be left as they are found when entering a paddock. If open leave it open and if closed, leave it closed.

PART VIII EXHIBITIONS C RETRIEVING, FIELD

14 Retrieving Trials – Gun Safety at Trials for Gundogs.

The following must be printed in each catalogue at all Retrieving Trials for Gundogs

15. Competitors:

- (a) It is the responsibility of any competitor in a Stake at a Retrieving Trial for Gundogs to observe Gun Safety at all times.
- (b) There is to be no training on designated trial grounds within 28 days before trial. **(07/19)**

16. Affiliate Member:

- (a) The Affiliate Member conducting a Retrieving Trial for Gundogs should ensure that all competitors are familiar with Gun Safety and Gun Handling.
- (b) The Affiliate Member shall conduct gun safety instruction to each competitor before each stake. This instruction shall cover the following points;
 - (i) The competitor must be familiar with the gun being used in the Stake;
 - (ii) It is the competitor's responsibility to ensure the barrel is clear of any obstruction before moving from the Control Point;
 - iii) The gun must never be pointed towards any person; and
 - (iv) The gun must be broken before returning it to the Gun Steward.
- (c) The Affiliate Member must ensure the Gun Steward possesses a bona fide firearms licence of the appropriate class. Gun Stewards and their licence numbers are to be added to the SACA marked catalogue.
- (d) Safety of the general public must be observed at all times.
- (e) Unused guns to be unloaded and securely locked away out of sight at all times.

PART VI

CATALOGUES

A GENERAL

1. The Catalogue for any Exhibition shall contain;

- (a) the name of each Exhibitor, except for Lure Coursing; **(01/16)**
- (b) the name of each Judge and the Class, Breed, Trial, Competition, Test or Stake he is judging; and **(01/13)**
- (c) a notification to the effect that;
 - (i) the Exhibition is conducted by an Affiliate Member of the SACA;
 - (ii) the Exhibition is held under the Rules of the SACA; and
 - (iii) a copy of the Rules of the SACA may be perused at the Office of the Secretary or Convenor of the Affiliate Member;

PART XIV

OFFENCES

A.

GENERAL

2. A Member shall be guilty of an offence if a dog owned, or leased, by the Member and exhibited at an Exhibition is or was;

- (f) dog present at Exhibition suffering from an infectious or contagious disease or had been exposed to the risk of such disease during the period dating from five weeks prior to the Exhibition. This also includes a dog brought onto the grounds at an Exhibition and is not exhibited; **(07/22) Maximum Penalty \$2000 (07/22)**
