Vetting & Check in: 8:00- 8:30am all dogs to pass checkpoint by close.

Entire Bitches only, vetting to be conducted by owner (i.e wiping vulva area to check for oestrus) and show to the vetting officer for Clearance

Dog Measuring: 8:00-8:30. For dogs without an approved height card. All dogs must have a height recorded prior to close of check-in

*Dog Heights - Under 30cm, 30 – under 45cm, 45cm & Over – **Dogs must be measured prior to competing.***

All dogs to pass checkpoint by close, dogs without a height card, please notify the club prior.

Judging commences: Not before 9am

Entry Fees: \$16 for ALCRC Members and \$22 for non-members

Running Order: to be confirmed on the day – Run sheet will be made available.

BOTS RESULTS will be available after the last state competition in October.

Important SprintDog™ Trial Details

- **Maximum of 3 dogs per household/registered owner.** Trial Manager and Secretary will exercise discretion on this definition
- People entering the event must organise their own handlers – All handlers must be financial members of an ANKC State body. All Handlers must be at minimum 16 years old
- One Handler releases the dog, another handler catches the dog at the end of the track
- The catcher can call the dog prior, and whilst the dog is running for encouragement but must be mindful of the body language displayed by the dog, as to not distract from chasing the lure.
- Dogs run individually after a lure down a straight course and are timed

IMPORTANT – The ALCRC Will be capping entries at 70 dogs plus committee and helper dogs. Any Entries received once the cap is reached will be returned. Please ensure catcher and releaser are noted with entries. Trial is subject to SprintDog™ Hot Weather policy, The Trial will not continue if the temperature reaches an average of 32 degrees Celsius. The affiliate must have a thermometer at the secretaries' desk for all to see. The "average temp" is calculated by the addition of the temperature in the sprint zone (unshaded) and the temperature in the shade, divided by two. If the "average temp" exceeds 32 degrees Celsius the SprintDog™ Trial shall either be postponed for fifteen minutes or closed. If after fifteen minutes the "average temp" still exceeds 32 degrees Celsius the SprintDog™ Trial must be closed. Entries will not be refunded
