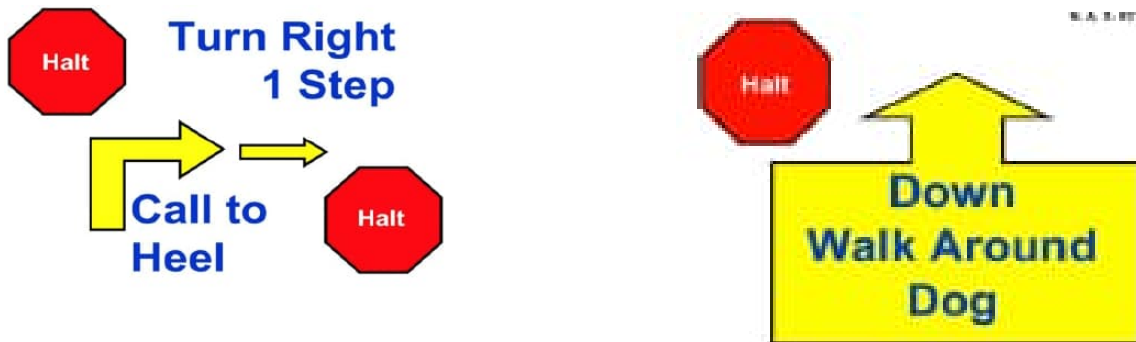
There are some handlers with multiple dogs and/or entries in more than one class.
