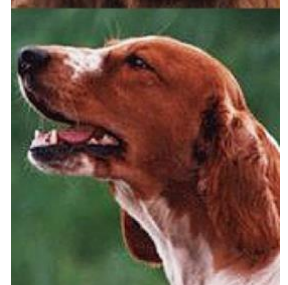

CATALOGUE

Please check that all dog & handler details are correct & notify the Trial Secretary if there are any errors. Please ensure details on pass cards are correct.

Demo dogs may run before scheduled start time. Judges, helpers and stewards may run prior to start time or at any time

Your catalogue number is also your run order number. A large number of competitors have requested to run early. Where possible, this will be accommodated and competitors are asked to be flexible and show good sportsmanship at all times.

PRESENTATIONS

Presentations will be conducted after the completion of judging of both classes and paperwork & scoring is finalised.

If you need to leave before presentations, please make arrangements for someone else to collect your pass card or any prizes you may win. Please note, the club will not be mailing out cards or prizes.

RULES

It is the responsibility of competitors to familiarise themselves with all rules with special attention drawn to the following;

3.3 Anyone taking part in a trial who openly impugns the actions or decisions of the Judge shall render themselves liable to be debarred from further participation in the trial and may be ordered from the grounds and further dealt with in accordance with the rules of the relevant member body.

13.12 Competitors may not divulge any information about the search, the location of the hide, or details of their performance until all teams have run for the particular class. Breach of this rule will result in disqualification from all classes and all results achieved to that time on that day will be voided.

PARKING

Parking is in front of the Boxhall Pavilion only. Parking for judges, stewards and helpers is in front of the office. Please refer to the map below.

CATERING

There is NO catering available on the grounds however there are take away shops on Westernport Highway within 5 minutes drive of KCC Park.



TRIAL PRECINCT

The search areas will be the area behind the Westernport /German Shepherd Dog Club rooms and the area behind the storage sheds (as indicated on the map.)

Competitors are not to enter out of bounds areas (marked with an X) or to park or walk on the gravel area on the northern end.

ALL fenced off leash areas are out of bounds for the duration of the trial. There is PLENTY of space to walk and toilet your dog. If in doubt, please check with the Trial Secretary. Competitors are also reminded that dogs must be on a lead at all times.
