The BDOC is affiliated with the Victorian Canine Association Inc.(VCA) and the fixture is held under the rules and Regulations of the VCA. A copy of the regulations may be perused at the office of the secretary of the fixture.

Please note that all dogs must be kept on lead at all times within Victoria Park Grounds and on the streets and surrounding areas. Please adhere to trial officials instructions when in the trial area.

Please be mindful of responsible dog ownership and keep your dog under control and on lead over the weekend, please ensure you have poo bags on you and use them when necessary. When taken to your tracking area, you are reminded that competitors are asked to stay within the vicinity of the parking area until directed by the judge or steward/s.

Tracklayers: Most tracklayers will be arranged in advance by the judge but in case the unexpected occurs, please have a start article and three TSD articles on your person so you can lay a track if required and please read the rules as to articles for Track and Search.

Please also check your equipment make sure that leads and harnesses are not frayed or broken, make sure that they are all in good working order.

There will be no catering at this trial but there will be coffee and tea available at the clubrooms.

CLUB POLICY – only 2 dogs to be worked on the one day by one handler and same handler to lay one track only.
