CONDITIONS OF ENTRY

1. The Club reserves the right to make any changes that will ensure the smooth conduct of the trial, to substitute or appoint additional judges, and to accept or reject entries. Dogs NSW regulations allow contracted judges to compete in the trials, provided they do not do so in the classes they have been contracted to judge.
2. These trials shall be conducted in accordance with the recommendations of Dogs NSW and the ANKC. Any additional requirements will be available on the Club's Facebook page and will be made available to all entrants. All officials, competitors and attendees shall agree to abide by the direction of Club Officials in relation to enforcing Club and trial requirements.
3. Competitors must only enter the classes they are eligible to enter.
4. There must be only one dog and handler per class. Any owner entering two dogs in the same class must advise the name of a second handler (who must be registered with a member body). Owners of two dogs in the same class will be run consecutively
