- The Club reserves the right to make any changes that will ensure the smooth conduct of the trial, to substitute or appoint additional judges, and to accept or reject entries. Dogs NSW regulations allow contracted judges to compete in the trials, provided they do not do so in the classes they have been contracted to judge.
- These trials shall be conducted in accordance with the recommendations of Dogs NSW and the ANKC. Any additional requirements will be available on the Club's Facebook page and will be made available to all entrants. All officials, competitors and attendees shall agree to abide by the direction of Club Officials in relation to enforcing Club and trial requirements.
- Dogs must be under the age of 8 at the trial date, Helmets must be worn for all bike riders, and the Vet Check paperwork must be handed in on the day of the trial.
- No Bitches in season allowed on the grounds.
