### **CHECK IN 7.30am – 8.30am**

Check in during this time and collect your exhibitor number. Any numbers that are not collected during this time will be scratched and will not be able to compete in the trial.

### **VETTING 7.30am – 8.30am**

All bitches (Including desexed) must be vetted before the official start time of the SprintDog™ Trial. Bitches in season and/or showing a discharge characteristic of being in season shall not be eligible to compete in a SprintDog™ Trial. and may not be in the trial precinct.

### **MEASURING 7.30am – 8.30am**

Measuring will be conducted prior to check-in for dogs that do not have a SprintDog™ Height Card or Dogs Australia approved Height Card or are under the age of two  
SprintDog™ Height Card - \$5.00 per dog. Cash payable on the day of trial to Dogs Victoria SprintDog™ Committee.

### **BRIEFING 8.45am**

All entrants and handlers are required to attend the briefing.

### **JUDGING 9.00am**

The trial will be officially started by the Trial Judge.

**CATCHER/RELEASER HANDLERS** Each entry is to organise their own Catcher and Releaser handlers. Please ensure both the Catcher and the Releaser handlers each have a lead. Both handlers need to display exhibitor numbers. All Owners and Catcher/Releaser handlers must be financial members of Dogs Victoria (or ANKC member body). Membership numbers of all handlers must be completed on the Show Manager entry. Enclosed footwear and weather appropriate clothing must be worn by Catcher and Releaser handlers. All Handlers must be over 16 years of age (and members of a Member Body. Handlers and Catchers under 18 years of age, must be a junior member).

**COLLAR** Only one item of permitted restraint is allowed on the dog. Dogs may run with or without a correctly fitted flat collar. Any item attached to the collar (such as name tags, council tags) must be taped up so that it is unable to be caught in the string. No check chains, haltis, prong collars e-collars and/or martingale collars are permitted. Dogs must not run in a harness or any other restraint other than a fitted flat collar.

**DISABILITY/HEALTH CONCERNS** If you have a disability, hearing impairment, vision impairment or health condition, please contact the Trial Secretary to discuss your personal requirements prior to the day of the trial.

### **DOGS UNSUCCESSFUL IN THEIR FIRST RUN, CANNOT HAVE A SECOND RUN UNTIL AFTER THE CONCLUSION OF QUALIFYING DOG RUNS (IF TIME PERMITS)**

Before entering any trial always ensure your dog is sound and moving comfortably, not recovering from injury or surgery and is fit for short bursts of speed. If you have any concerns about your dog's health or mobility, you should seek veterinary advice before entering a trial.

White Swiss Shepherd Dog Association of Victoria Inc is affiliated with Dogs Victoria.

The trial will be held under the rules and regulations of Dogs Australia and Dogs Victoria. The Committee retains the right to close entries early if entries reach a high number or cap. Judges and Officials may enter and or handle dogs in this trial and are included in the cap.

The Committee reserves the right to substitute Judges or Lure Operators if required.

A copy of the rules will be available from the office of the Trial Secretary.

Weather/Extreme weather – Dogs Australia Regulation 2.8 & Dogs Victoria Regulation 3.5.20 & Regulation 16.10 will apply to this event.
