ALL DOGS ON THE TRIAL GROUND MUST BE KEPT ON LEAD (held in hand, securely tethered, or crated) except when competing. Please be aware of a very busy main road running parallel to the property. Dogs are not permitted to be allowed to interact with livestock that may be in the vicinity of the trial area.

PLEASE DISPOSE ALL RUBBISH THOUGHTFULLY!

Under no circumstances are competitors to return to the trial grounds following the trial or seek permission to train or hunt on the grounds.

SAFETY BRIEFING FOR RETRIEVING TRIALS

Trials are held over undulating and hazardous terrain; it is suggested that sturdy footwear and clothing be worn to reduce the possibility of scratches or injury. As with all outdoor activities it is suggested competitors and spectators have appropriate clothing for the weather and take due care when moving around the trial site.

The environment, animals and wildlife can be inhospitable. Be alert and avoid any inhospitable animals and wildlife where possible.

Trials may be located near water. If you cannot swim take care of the water. If you have children in your custody, it is your responsibility to always ensure the safety and welfare of the children.

Equipment used in trials is mechanical and if used incorrectly could cause injury. If you are unsure regarding the operation of the equipment familiarise yourself with how the equipment works before use.

We are privileged to be invited on to properties to run our trials and must respect the property owner's personal property and should therefore:

- Remove all your rubbish from the property.
- Do not enter any dwelling on the property.
- Do not touch any farm equipment on the property.
- Ensure dogs are always kept under control especially around any livestock and the main road.
- All gates must be left as they are found when entering paddocks.
- A first aid officer is available on the trial site and if first aid is required, please contact the Trial Manager.
