**There must be only one dog and handler per class.** Any owner entering two dogs in the same class must advise the name of a second handler (who must be registered with a member body). Owners of two dogs in the same class will be run consecutively

**Judging and Check in:** Briefings in person for opening the trial and walkthroughs posted online 15 mins prior to judging commencement of each class.

### Trial 1: Friday 31 July 2026

**Ultimate: Session 1:** Check-in from 9am. Ultimate judging commences 10am.

**Session 2:** Check-in from 11 am – Start after completion of Session 1 and judges' lunch

### Trial 2: Saturday 1 August 2026

**Ultimate: Session 1:** Check-in from 7:30am. Ultimate judging commences 8:30am.

**Session 2:** Check-in from 9:30am – Start after completion of Session 1 and Judges' lunch

**NOTE: To enter the ultimate class at this Scent Work Trial an entry must have gained two element titles which is shown the dogs registered pedigree name prior to entering the class."**
