ENTRY INFORMATION: To be eligible to enter the Ultimate Class at any DOGS NSW Sanctioned Scent Work Trial, a dog must have gained a minimum of two (2) Element Titles. These titles must be recorded on the dog's registered pedigree name prior to entering. Competitors may only enter ONE dog per husehold for Ultimate. If space allows closer to the closing date competitors may enter an additional dog.

A dog may NOT be entered in the same element across different classes. For example: a dog MUST NOT be entered in Advanced Containers and Excellent Containers or Masters Exteriors and Excellent Exteriors.
