Jump height to be stated for each dog entered in Open, Utility, Rally Advanced & Excellent classes. **Entries must be from the Group 5 breeds listed on the Main or Limited Register to be accepted as a condition of entry.** GSDCV membership to be noted on entry. The GSDCV reserves the right to add to, change class distribution or reduce the judging panel depending on entries received. For Dual Trophy purposes: (GSD Obedience entries also competing in conformation classes at the GSDCV Championship Show) please indicate on entry which conformation class dog will be entered in.
