A 'RESTRICTED STAKE' is a stake confined to Gundogs that have not won five (5) Restricted Stakes or an All Age Stake or been placed first or second in a Championship Stake.

An 'ALL AGE STAKE' is a stake confined to Gundogs that have won a Novice or have been placed first, second or third in a Restricted Stake.

TRIAL VENUES: Properties used for Trials are private properties and **MUST NOT** be revisited after the trial. Entry for the Trial is subject to this condition.
